## New Subdivision on Lower Springy Pond

New neighbors soon to be arriving

For the first time in forty years, there is a new subdivision on the shores of Lower Springy Pond. The shorefront property formerly owned by Bangor Water District was recently purchased and has been subdivided. This subdivision consists of six new approximately one-acre lots with shore frontage ranging from 209 feet to 342 feet. We understand that all six lots have been sold, and that new construction is underway on five of the six lots. When you meet each of your new neighbors, please welcome them to the Springy Pond community.

As some of you may recall, Prentiss and Carlisle made the first subdivision on Lower Springy Pond in Otis in 1961. This subdivision consisted of twenty-eight leased camp lots on the westerly shore of Lower Springy Pond in Otis. At that time, the Town of Otis did not have a Shoreland Zoning Ordinance in place so there were few restrictions with regard to building setback requirements and the clearing of trees. Today's requirements are more restrictive where new building construction must be greater than 100

feet from the water and the clearing of trees within 100 feet of the water is limited.

This subdivided property was formerly owned by Bangor Water District. After Bangor Water District was formed in 1957, Legislative Charter granted it in 1958, in addition to Floods Pond, the rights to draw water from Beech Hill Pond and Lower Springy Pond. In 1959, the District purchased approximately 6.9 acres of land with 1,500 feet of shore frontage on Lower Springy Pond for the purpose of constructing a pumping facility if future demands required the development of an additional water source. The nature of the District allowed it tax-exempt status from the Town of Otis. As the District's land holdings increased over the years, the Town became concerned with the loss of taxable property. In 1995, the Town and the District reached an agreement. Part of that agreement was for the District to relinquish its water rights to Lower Springy Pond and to sell its shorefront property on Lower Springy Pond.

Bangor Water District's water rights to Lower Springy Pond were relinquished in the summer of 1995 when the Legislature approved amendments to the Charter. The District then offered the property for sale by sealed bid. In October 1995, the property was sold to Stockade Group. ❖
